South Carolina Poultry Festival Food Concessions

You are invited to participate with The South Carolina Poultry Festival as a Food Concession Vendor. The festival is the **2nd weekend** of May and will be held **May 9, 10, and 11, 2019**. Spaces are located in two zones. **ONLY FOOD ITEMS WILL BE SOLD IN THESE SPACES!!!!**

Zone number **one** is located in the DOWNTOWN AREA (from East Railroad Avenue to Highway # 23). Set up time will be **Thursday May 9 AFTER 12:00 p.m. (NOON)**. You can open for business Thursday night, Friday night, and all day Saturday until close of the festival each evening. Cost is \$900.00.

Zone number **three** is located in the DOWNTOWN AREA also, (including East Railroad Avenue to Highway # 1). You may open for business **Friday night BUT cannot begin setup or occupying your space before 6:30 p.m. Friday night May 10. ABSOLUTELY NO EXCEPTIONS!!!!** Cost is \$800.00.

You will be required to display THE SOUTH CAROLINA POULTRY FESTIVAL FOOD VENDOR FORM, have your proof of insurance, tax identification number, items you will be selling, site location, set-up and business opening time. You are also required to have a working and correct type fire extinguisher on hand for your business during your stay at the festival.

PLEASE NOTE THE FOLLOWING:

- 1. You will be inspected by the Batesburg-Leesville Fire Marshal and must be in compliance to participate.**
- 2. You must have a SC Retail License in accordance with the SC Dept. of Revenue.**
(For registration please contact 1-844-898-8542. Choose Option 2, then Option 2 or email TaxRegistration@dor.sc.gov.)
- 3. Pricing for your items must be displayed during the festival hours of operation.**

All spaces will be assigned on a LIMITED basis. The assignment of spaces by the Steering Committee, specifically the Food Vendor Committee, and are FINAL. Absolutely no refunds will be issued after your space has been assigned.

We are looking forward to seeing you on **May 9, 10, and 11, 2019**. Please return your application promptly by **March 1, 2019** with your check payable to The South Carolina Poultry Festival in order to be considered for a space. Additionally include a copy of your **liability insurance policy** and a **self-addressed stamped envelope** for acceptance and space assignment.

You are only permitted to sell food items that are on your application and all food related items are subject to final approval. Approval will be given in writing on the Zone/Space assignment form.
